5. Cr Bech Report - Circulated

 Tamahere Reserve/Piazza update — A firm has been chosen to lead the design phase, concept designs will then come back for consultation.
 Concept designs for the fit out of Building C — WDC office space out shortly.

- Fitness Trail no update.
- Permanent Toilet block no update
- Carving donated by Arnold Koppens Fabrication of freestanding frame to display it completed and powder coated to match the joinery colour. Work continues with Ngati Haua on wording of the story of Tamahere. Position of story board undecided.
- **Hub Security** expert from safercities.com to do a site visit in Febuary and advise on what might be effective with regards CCTV in the area.
- E- Charger at the Hub no further progress awaiting outcome of EECA funding application.
- **WDC 'give back' day** ½ day scheduled for March 26. TCC asked for ideas for this working bee.

6. Service Delivery – Tamahere Community Committee Issues Report - circulated

Car/Bus parking on Wiremu Tamihana Drive – In December TCC wrote to WDC requesting a revision of the Hub parking plan of proposed changes to include bus stops. That designers meet as soon as possible to discuss.

- Response indicates no changes to public transport in Tamahere until East/West link opened, possible closure of Devine Rd at School end decided and community surveys completed. WDC unsure of routes so feel placement of bus stops is premature. WDC needs to work with WRC.
- TCC unsure why a provisional space for buses hasn't been allocated. Has been under discussion since 2017. There are multiple bus groups using the hub parking area.
 Suggested that the buses currently using the space on the on ramp be moved to a centralised space at the Hub. No word on WDC meeting with TCC to discuss. Concern that a whole strand of buses are not being considered.
- Cr Bech reports Tamahere is now being included in the Hamilon Metro Spatial Plan, buses from Hamilton will likely circuit through Tamahere. A precinct plan is currently underway by Luke McCarthy (not WDC adopted).
- TCC notes that parking for the Hub Pub does not seem adequate.
- Action; Sue will continue communications with Paul Mc Pherson.
- Action; Cr Bech to Approach Gray Matter for an update to the local council plan considering impact of southern links, closure Devine RD school end, Pedestrian access across SH21

Hub Stage Plans – BCD has been awarded the contract. Will provide 2 basic concept designs for community consultation.

Fitness Trail – construction begins shortly.

Tamahere Hub Car Park – resurfacing, remarking and signage being scheduled.

Tamahere Park Toilet – a design brief is being finalized prior to commissioning an architect. Plan for remote construction and for external style to be developed with the community. Preliminary designs/location/aspect will be provided for community feedback.

Annebrook Lane new connection to Matangi Rd – awaiting final costs and timing. Work expected to start in February.

WDC Presence at Tamahere Hub supported by TCC – media release will be done once all parties have signed documents

7. Other Business

Connectivity subcommittee

James has met with NZTA planner Sarah Loynes who will come to the TCC March meeting as well as local and central government reps.

Gully Walkway Subcommittee

Members have responded to the draft MOU as presented by Kim Wood. It may be appropriate to look at another vehicle rather than a Trust.

A University of Waikato student has mapped the local gully systems.
