- The astrograss was groomed and treated for fungi bi annually.
- Tennis was played in the n summer and netball in the winter.

<u>Pokeno Community Patrol – Replace Patrol Vehicle</u> Agenda Item 6.2

Mr Grainger, Mr Rowe and Mr Armstrong noted the following matters:

- Pokeno township is rapidly growing.
- The current patrol vehicle had done 200,000kms.
- Patrolling took place seven days/week.
- The patrol group were the eyes and ears and had backing of local police.
- The aim is to make Pokeno safe.
- The group had 30 volunteers and it took approximately 3 hours to patrol the Pokeno area.
- The Police Station was manned only during the day.
- An SUV (sport utility vehicle) sits higher off the ground and was easier for some members to get in and out of.
- The group constantly fundraises for fuel and maintenance.

3. BACKGROUND

The Dynamo Cycling & Sports Club is hosting the 2021 Road Cycling Event - Race 4 of the Dynamo Team Championships (6 race series).

The event will take place Sunday 17 October 2021, starting at the Waipa Primary School in Ngaruawahia. Riders will journey through Huntly, Glen Murray, Whaingaroa and Glen Massey before finishing at the start line.

The Team Championships has 60 plus teams taking part in seven different grades, with the grades providing opportunity for riders to compete in a range of events applicable to their skill level.

It is anticipated 350 – 390 competitors will participate, with in excess of 250 supporters in Ngaruawahia and it will attract 500 people outside the region, promoting the Waikato district. People will have the opportunity to explore local attractions and activities, such as the Te Awa Cycleway.

40 volunteers help out with this event. Considerable existing funds will contribute towards required funds and various Gaming Trusts will be approached too.

- 4.1 That the application is approved and an allocation of partial or full funding requested be made.



1. Statement of Accounting Policies

Entity Reporting

These financial statements are for DYNAMO CYCLING & SPORTS CLUB INCORPORATED.

Statement of Compliance and Basis of Preparation

The Special Purpose Financial Statements of DYNAMO CYCLING & SPORTS CLUB INCORPORATED, have been prepared in accordance with the stated accounting policies. The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historical cost and accrual basis have been applied. The Special Purpose Financial Statements of DYNAMO CYCLING & SPORTS CLUB INCORPORATED, are prepared to meet the requirements of Rules of the Society.

Measurement Base

The accounting principle recognised as appropriate for the measurement and reporting of earnings and financial position on a historical cost basis are followed by the entity. Reliance is placed on the fact that the entity is a going concern.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied.

(a) Foreign Currency Translation

Foreign currency translations are converted at the New Zealand rate of exchange ruling at the time of the transaction. At balance date, foreign assets and liabilities are translated at the closing rate and any variations arising from these translations are either included in the Statement of Financial Performance or otherwise disclosed in the financial statements.

(b) Fixed Assets

Fixed Assets are stated at original cost price less accumulated depreciation, and are recorded on the Statement of Fixed Assets & Depreciation that form part of these financial statements.

(c) Depreciation

Depreciation has been calculated using the maximum rates allowed for taxation purposes. The particular rates and method of depreciation applied are as recorded on the Statement of Fixed Assets & Depreciation. A contingent taxation liability exists on any depreciation that may be recovered on the sale of Fixed Assets.

(d) Intangible & Other Assets

Intangible & Other Assets are recorded at cost, less amortisation in accordance with rates available under the Income Tax Act.

(e) Income Tax

No Provision has been made for taxation.

Due the the company's amateur sport promoter status, it is exempt from Income Tax.

(f) Goods and Services Tax

The financial statements have been prepared on a GST exclusive basis where all items in the Revenue Accounts and Fixed Assets have been recorded exclusive of GST. GST owing to or by the entity at balance date as recorded in the Statement of Financial Position, has been determined on an accruals basis.

(g) Changes in Accounting Policies

There have been no changes in Accounting Policies. All policies have been applied on bases consistent with those used in previous years.

2. Contingent Losses and Gains

There were no known contingent losses or gains outstanding as at balance date.

3. Related Party Transactions


