## TERMS OF REFERENCE

### COUNCIL

<b>Chairperson:</b>	Her Worship the Mayor
<b>Deputy Chairperson:</b>	Deputy Mayor
<b>Membership:</b>	The Mayor and all Councillors
<b>Meeting frequency:</b>	Six weekly – or as required
<b>Quorum:</b>	Half of the members (including vacancies)

### Purpose

1. To provide leadership to, and advocacy on behalf of, the people of the Waikato District.
2. To define and represent the total communities' interests, ensuring ongoing community and economic development, the effective stewardship of existing assets, sustainable management of the environment, and the prudent management of the communities' financial resources.

### Terms of Reference

The Council's terms of reference include the following powers which cannot be delegated to committees, subcommittees, officers or any other subordinate decision-making body:

1. The power to make a rate.
2. The power to make a bylaw.
3. The power to borrow money, or purchase or dispose of assets, other than in accordance with the Long-Term Plan.
4. The power to adopt a Long-Term Plan, Annual Plan, or Annual Report.
5. The power to appoint a Chief Executive.
6. The power to adopt policies required to be adopted and consulted on under the Local Government Act 2002 in association with the Long-term Plan or developed for the purpose of the local governance statement, including the Council's Infrastructure Strategy.
7. The power to adopt a remuneration and employment policy.
8. The power to approve or amend the Council's Standing Orders.
9. The power to approve or amend the Code of Conduct for elected members, and consider any recommendations made in relation to a complaint lodged under the Code.
10. The power to appoint and discharge:
  - a. members (including chairpersons) of Council committees and subordinate decision-making bodies, subject to the Mayor's powers under section 41A Local Government Act 2002; and
  - b. elected member representatives on external organisations.
11. The power to establish a joint committee with another local authority or other public body and appoint elected members as representatives on such committees or bodies.
12. The power to make the final decision on a recommendation from the Ombudsman where it is proposed that Council not accept the Ombudsman's recommendation.
13. The power to approve or change the District Plan, or any part of that Plan, in accordance with the Resource Management Act 1991.

14. The power to amend or replace the delegations in Council's Delegations Register (except where expressly permitted in the Delegations Register).

To exercise the following powers and responsibilities of Council, which the Council chooses to retain:

1. To approve a proposed policy statement or plan under the Resource Management Act 1991.
2. To approve changes to boundaries of the District under the Resource Management Act 1991 or any other legislation.
3. In respect of District Plan decisions:
  - a. To appoint independent commissioners to a panel for hearings of a Proposed District Plan;
  - b. To approve the recommendation of hearings commissioners on a proposed plan, plan change or variation (including private plan change); and
  - c. To approve a proposed plan or a change to a district plan under Clause 17, Schedule 1 of the Resource Management Act 1991.
4. To adopt governance level strategies, plans and policies which advance Council's vision and strategic goals (e.g. Hamilton to Auckland rail), other than where expressly delegated to a committee.
5. To approve Council's recommendation to the Remuneration Authority for the remuneration of elected members.
6. To approve the Triennial Agreement.
7. To approve resolutions required to be made by a local authority under the Local Electoral Act 2001, including the appointment of an electoral officer and reviewing representation arrangements.
8. To approve any changes to the nature and delegations of any Council committees or subordinate-decision making bodies.
9. To approve the Local Governance Statement.
10. To approve funding requests not allowed for within budgets, in accordance with Significance & Engagement Policy parameters.
11. To approve any additional funding decisions required for the Watercare Services contract.
12. To approve development agreements as recommended by the Development Agreements Subcommittee where infrastructure is not allowed for within the Long Term Plan.
13. To receive six-monthly reports from each Community Board on its activities and projects.

## **1. Purpose of the report**

### **Te Take moo te puurongo**

---

To enable the receiving and hearing of submissions on the proposed targeted rate for Tamahere Gully Network Restoration.

## **2. Executive summary**

### **Whakaraapopototanga matua**

---

During 2022, the Tamahere Community Committee requested a targeted rate of \$1 per week per property be put in place for the pre-2022 Tamahere Ward local community over the next five years. The funding collected would fund the Tamahere Mangaone Restoration Trust to carry out gully restoration and maintenance and provide community education and awareness.

A public consultation took place between 6 April and 25 May 2023. A total of 231 submissions were received on the proposed targeted rate.

## **3. Staff recommendations**

### **Tuutohu-aa-kaimahi**

**That the Waikato District Council, pursuant to section 82 of the Local Government Act 2002, considers all submissions and, where requested, hears submissions on the proposed targeted rate for Tamahere gully network restoration.**

## 4. Background

### Koorero whaimaarama

---

In 2022, the Tamahere Community Committee, on behalf of the Tamahere Mangaone Restoration Trust (the Trust), requested a targeted rate of \$1 per week per property for the pre-2022 Tamahere Ward be put in place for the local community over the next five years to fund restoration works in the Tamahere Gully area.

The funding collected via the targeted rate would fund the Trust's restoration works within Council land and reserves or on private land with public accessibility. Works would include gully restoration and maintenance, and community education and awareness. The Tamahere walkway project, funded in the 2021-2031 Long Term Plan over multiple years, would also be able to be completed earlier than anticipated.

In accordance with section 82 of the Local Government Act 2002 (LGA), consultation has been undertaken with the community, with direct communication to those in the area that would be directly affected by the proposed targeted rate.

## 5. Discussion and analysis

### Taataritanga me ngaa tohutohu

---

Public consultation was initially undertaken between 6 April and 7 May 2023 to engage with ratepayers in the proposed targeted rate area and invite submissions on the proposed \$52 rate. Staff used the following communication methods:

- Media release;
- Council's Facebook page;
- Direct letters to all properties in the proposed targeted rate area;
- Emails to Tamahere-Woodlands Ward Councillors and the Tamahere Community Committee to cascade to their networks.

Two drop-in sessions were run by the Tamahere Mangaone Restoration Trust (these were supported but not managed by staff) during the consultation period, to provide more information to the community.

In the lead up to the consultation closing, it was identified that further information about the 2023/24 Annual Plan was relevant for the community to inform their submissions, including the availability of the Rating Information Database (RID), which was made available online on 12 May 2023. Consultation was then extended to 25 May 2023 and additional communication went out as follows:

- Email to all those that had submitted already, notifying them of the extension and the additional information; and
  - Direct letters to all properties in the proposed targeted rate area, also notifying them of the extension and the additional information.
-

A district wide letter about the draft 2023/24 Annual Plan, 7 per cent rates increase, and the link to the RID was sent out at the same time as the above. This general letter did not include details to the rest of the district about the proposed Tamahere targeted rate or consultation.

While the draft Annual Plan and 7 per cent rates increase was not being consulted on with the public (as per the [Council report on 5 April 2023](#)), the distribution of the district wide letter did result in some feedback received from the community, which staff wanted to acknowledge and bring to Council's attention. At the time of writing, 31 emails had been received directly relating to the proposed rates increase, all of which expressed disappointment and/or outrage about the cost of the increase.

These emails are not formal submissions and are not counted as part of the consultation on the Tamahere targeted rate. Some of these emails requested further details about what their rates pay for and/or requested further information about rates relief options. Where information was specifically requested, staff have responded to those requests.

### **Submissions**

Shape Waikato is Council's main portal for engagement with the community. The Tamahere targeted rate page on Shape Waikato received 1153 views and 642 individual visitors. In total, Council received 231 formal submissions. 13 submitters requested to be heard although this number is likely to reduce as hearings scheduling progresses.

### **Hearings pack**

The hearings pack consists of this report, the hearings schedule (attachment 1 – subject to change) and a copy of every submission received during the consultation period (attachment 2).

## **5.1 Financial considerations**

### **Whaiwhakaaro puutea**

There are no material financial considerations associated with the recommendations of this report.

## **5.2 Legal considerations**

### **Whaiwhakaaro-aa-ture**

Staff confirm that the staff recommendation complies with the Council's legal and policy requirements. Consultation on the propose targeted rate occurred under section 82 of the Local Government Act 2002.

As mentioned in the report, consultation was extended, and additional information was provided to those impacted by the targeted rate, to ensure they had information about the 7 per cent general rate increase for 2023/24. This was done to ensure all obligations under section 82 were met.

- There is no legal requirement to consult using the Special Consultative Procedure (SCP) in accordance with the Local Government Act 2002 (LGA), as Council's Revenue and Financing Policy allows for targeted rates to be collected in relation to the parks and reserves activity. Section 82 of the LGA was used for targeted consultation with the affected community.
  - The proposed targeted rate is low and does not meet the 10 per cent threshold for higher significance.
  - Some community views on the proposals are already known, however it is important to provide the whole Tamahere community with the opportunity to express their views.

Submission from Waikato Regional Council to Waikato District Council's 2023/24 Draft Annual Plan

Introduction

1. We appreciate the opportunity to make a submission on the Waikato District Council's 2023/24 Draft Annual Plan.

2. We would like to speak to our submission.

Tamahere gullies

3. The Tamahere gullies were identified as a priority site in the biodiversity prioritisation process that was carried out for the Waikato region.

4. The Tamahere gully supports largely secondary-regenerating and replanted native vegetation, providing important habitat for the critically endangered long-tailed bat, possibly for diadromous fish, and is the closest known breeding site to Hamilton for bellbird/korimako.

5. The gullies also provide key connectivity between Hamilton city, the Waikato River and restoration projects in the surrounding landscape (e.g., Hammond Park, Hamilton Halo, Predator Free Mystery Creek, Predator Free Cambridge, Maungatautari and Pirongia etc).

6. The restoration work being carried out in the Tamahere gully system is crucial to promoting biodiversity in the area. We therefore support restoration work being carried out in the gully system and the resourcing would be beneficial to biodiversity, both in the Tamahere gullies and the surrounding landscape.

7. Predator control will be an important component to improve biodiversity outcomes in the gullies. This is currently being led by Predator Free Tamahere which was formed in 2022. We would prefer to see a targeted rate that is linked to specific restoration activities, and guided by a peer-reviewed management plan, rather than funding one community group directly. It is also important to note that all restoration activities should follow best practice techniques.

8. Overall, we commend the work of your Council and the other groups in this area. It is promoting a healthier and more diverse environment for the Tamahere gullies and the surrounding areas.

# Hamilton City, Waikato District & Waipa District Councils

- Working together to provide projects that the community needs, are transformational, and generates jobs after Covid19;
- HCC has submitted “*Development of Natural Area Gully Networks*” to Central Government as a \$103.5m “Shovel Ready” project for funding assistance;
- Maungaonua Gully is a \$22.22m part of that project (there are 4 other parts);
- This Greenway proposal is a more detailed community suggestion to utilise those funds.

## Benefit Highlights – HCC Proposal Section 15 (for whole Gully Project)

### ***“Environmental Wellbeing***

*Improves resident’s access to natural areas within the city, building a stronger understanding and appreciation of biodiversity in Hamilton. Contributes to significantly improved biodiversity value in the urban environment which will have positive flow on effects on climate change.*

### ***Social Wellbeing***

*An improved path network through gullies and natural areas can improve social wellbeing by providing more opportunities for residents to be physically active and enjoy their surroundings. This has a likely impact of encouraging further social connections.*

### ***Cultural Wellbeing***

*Natural areas are significant to Mana Whenua. Improved access by the community is likely to ensure that these values are shared and understood more widely and there is an opportunity to reinforce gullies contribution to the Waikato-Tainui Environmental Plan*

### ***Economic Wellbeing***

*The project expenditure provides a direct boost to the local economy. Not only this but the indirect and induced expenditure is expected to multiply the effectiveness of this funding. PWC has estimated in a report to the Construction Strategy Group the multiplier effect for construction. “That one dollar invested in construction produces between \$2.51 and \$3.11 in economic activity”. On that basis this project would return approximately \$290M in economic benefits.*

*Longer term, the pathways create another attractive aspect to Hamilton and encourage more people to live, work in and visit the city.”*

## Benefits of Mangaonua Rehabilitation – Community Views: 1 - 8

1. Rectifies part of the neglected landscape which cannot be remedied until better access is available. (Most cities have hills to provide character whereas Hamilton has Gullies instead. This gives Hamilton a unique feature.)
2. Provides a wildlife corridor from the Waikato River for native birds, bats and fish, linking existing significant native areas (SNAs).
3. Enables more efficient control of mammalian predators, especially possums, rats and stoats etc.
4. Removes problem weed species such as privet and contributes to the Government's "1 billion" trees initiative.
5. Provides highly appropriate recreational activities for "country living" – the transition zone between rural and urban living areas;
6. Is a labour intensive scheme, especially in its initial stages, and will largely utilise local resources
7. Will result in a significant public resource extending Hamilton's riverside walkways and will create a new network of non road pedestrian and cycle routes. Effectively it provides "parkland reserves" that are geographically integrated into the landscape
8. Could provide approximately 6 km of kayak accessible waterway

## Benefits of Mangaonua Rehabilitation – Community Views: 9 - 13

9. Provides easy access for continuous maintenance of a natural part of the landscape for the enjoyment of all.
10. Will provide a useful natural education resource for the several close by schools, the University and the Technical Institute.
11. Effectively provides natural native flora and fauna parks and waterways deeply integrated with physical landscape and avoids planned or inadvertent incursions by rapidly growing population. It resists the negative effects on the region from gradual urbanization that usually removes greenery, birds, lizards, fish and other native wildlife and increases pollution.
12. With the modest extra cost of good signage, will provide historical, geological, environmental and cultural links for everyone to become more knowledgeable about the world we live in. This is particularly important for our children.
13. If properly fenced (at significant cost), will provide native reserve areas free from domestic pets which harm birds and other native fauna.
14. If planted with some NZ Bush Nettle, especially where security is required, will bring back the threatened native red and yellow Admiral butterflies (kahukura and kahu kowhai).



## Background

- Councils have a network of pedestrian and cycle trails along the banks of the Waikato River, but have done little to link these to the often deep gullies which thread through the city.
- This contrasts unfavourably with New Plymouth where similar gullies support much loved and well used trails such as the Te Henui and Huatoki walkways.
- The longest and most significant of all the gullies in and around Hamilton is the Mangaonua and its tributaries, yet this is the least accessible gully system, despite its ecological, cultural and scenic value. Rehabilitating the Mangaonua has previously been thought desirable but requiring too much labour to be feasible (HCC Gully Reserves Management Plan December 2007).

## Mangaonua Gully Rehabilitation

- Hamilton City is largely devoid of hills but is crisscrossed by deeply incised gullies which give the city its distinct character
- The Mangaonua Stream and its tributaries including the Mangaharakeke, Mangaone Streams and other smaller gullies is by far the largest and most significant gully system in or adjacent to the Hamilton City area.
- It contains much of the significant natural area within the city and is currently very poorly accessed or utilised.
- Rehabilitation would enhance the gully system as wildlife corridors for native invertebrates, many of which are locally or nationally threatened.
- Although some gully rehabilitation has been undertaken within Hamilton City, the majority of this gully system has been unrestored because of the scale of work involved. This gully system has also been identified as a high priority for restoration by Waikato District Council (Waikato Regional Council Technical Report 2017/36). The Covid-19 recession 'shovel ready' funding has provided a rare opportunity to redress this as the work involved requires extensive labour.

## Current Status - Vegetation/Flora

The Mangaonua Stream is largely bounded by riparian reserves administered by Hamilton City Council and Waikato District Council.

The reserves are currently in poor state with serious infestation of weed species including:

- Willow (*Salix cinerea* and *Salix fragilis*),
- Privet (*Ligustrum* spp.) and
- Blackberry (*Rubus fruticosus* agg.)
- Gorse

There are significant clusters of native species that require extra conservation work including:

- Kahikatea,
- Totara,
- Coprosma spp.,
- Pseudopanax spp (incl Lancewood and 5 finger),
- other native broadleaves and
- Tree ferns (*Cyathea medullaris*, *Dicksonia squarrosa*, *Cyathea dealbata* and *Cyathea fibrosa*).

## Current Status - Wildlife/Fauna

- **Native birds** regularly sighted include:- Tui, Shining Cuckoo, Pukeko, Australasian Harrier, Waxeye, Grey Warbler, Fantail, Ducks (species not identified), New Zealand Kingfisher and Morepork.
- In addition rehabilitation of the gully system and predator removal are likely to encourage Kereru and Bellbirds to re-establish themselves.
- **Native fish** observed include:- Long finned eel, Short finned eel, Mudfish, Banded Kokopu, Common Bully, Crans Bully, Redfinned Bully and Common smelt.
- **Other native Fauna** include glowworms, long tailed bats and speckled skinks. Geckos may also be present.

## Stage 1: Cambridge Road to Matangi Road

### **Construction of an access track and weed removal**

The first phase of the Mangaonua Gully Rehabilitation Scheme envisages construction of two access tracks from Matangi Road to Cambridge Road with a bridge over the Mangaone Stream. One track will be within Hamilton City esplanade reserves and the other within Waikato District esplanade reserves. Initially these tracks will provide access for weed vegetation removal, predator trap lines and then replanting with appropriate native species.

Clarkson *et al.* (2007) indicates that the original vegetation on the gully floors would have been a kahikatea, pukatea, swamp maire forest and the valley sides with a tōtara, mātai and kōwhai forest. The fragments remaining of these forests will be augmented with new plantings resulting in a gradual replacement of most of the exotic tree species. Obstructive logs should be removed from the stream bed, and illegally dumped rubbish removed.

Fencing will be required to define boundaries between reserves and neighbouring private land and should be of a standard to keep domestic cats and dogs from straying into the esplanade reserves.

When the major rehabilitation work is completed the tracks could be paved suitable for walkers and cyclists. A bridge across the Mangaone stream will be required on the Waikato District bank of the Mangaonua. A small car park should be constructed off Matangi Road with access to the stream for kayakers.

Crossing State Highway 26 from the Matangi Road intersection allows access to the partly constructed "Gown to Town" trail around Silverdale.

We heartily support the proposal for gully restoration funding. Most of the WDC owned (and private) gully areas are weed-strewn ruins, choked with willow, honeysuckle and many other smothering weeds. Many of the streams are partially blocked by weeds which results in flooding and erosion. We are disappointed that the WDC is not more pro-active in restoring these areas to their original native forests - to leave this to volunteers is unbelievable.

However, as pensioners, we would find it financially difficult to pay yet more rates. While we were both in paid employment, we spent a lot to money and time restoring our 6 acres of gully adjoining the Mangaharakeke Stream. We grew most of the native plants needed from seed collected from local bush remnants. 35 years later it is now a self-managing swamp and lowland forest with numerous seedlings of kahikatea, pukatea, swamp maire, totara, etc. coming up. The area is now QEII covenanted. The change from when we first bought the property is stark. You couldn't progress down there without a chainsaw in front of you. Masses of fallen willow entwined with honeysuckle and other vines. Once, when chain sawing through the mess I looked down to see running water below - the Mangaharakeke Stream! It is now cleared and flows with kahikatea along its banks.

So, our area does not need restoring. However, we strongly support the restoration needs of much of the rest of our local gullies. The source of funding for this is challenging. We would contribute half of the suggested \$1/ week if the WDC made an equal contribution. This would surely be more acceptable to the rate payers and would give a clear indication that the WDC is environmentally responsible. As global warming accelerates, flooding will become an increasing problem, and it is critical that these streams are clear of debris (slash!). Flooding will produce bank erosion and slipping of what are water deposited sediments with the collapse of paddocks and houses.

**1. Objection to the TGN proposal.**

Tamahere is one of Hamilton's wealthiest suburbs. The most expensive properties are associated with the 3 main streams. There can be no argument of public affordability. As a practical example when I purchased my property in 1999 it comprised 2 paddocks. The bottom paddock was used to winter dairy grazers. It had 3 unfenced streams and two significant ponding/seep areas. Every year it was turned into a bog which drained directly into the Mangaone stream. along the waterways. It was easy for me to recognise this wasn't great stewardship. I fenced all streams and retired half of my 2.5ha planting it in natives. The only interest shown by the District Council was to send me a brochure outlining my native plantings as being a significant natural area. The irony of the district council mandating protection, because they presumably do not fully trust me to look after the native bush I have planted and sprayed 5 times a year for the first 8 years should be clear.

It is with disappointment that the wealthy folk of Tamahere want me to subsidise their very belated efforts.

**2. Objection to the submission process**

It is becoming a frequent phenomenon, that I get these brochures in the mail that do not contain the essential facts of the proposal, but invite me to a single "opportunity to view the plan" which occurs during the working week and at 3pm in the working day. This cannot be considered adequate where the outcome is an increase in my costs. I cannot easily make these working day appointments. The Council should be careful of asymmetrical processes that favour council's staff availability.

These two stories contain the essence of an experience I had recently. It was a church yard that was infested with out of control roses that had not only overtaken the church yard but had started on the neighbours.

About 30 years ago a member of the congregation had donated the cost of establishing a rose garden in memory of her recently deceased husband. She looked after it for a couple of years until she died. Parish members took over after her departure but slowly the number of volunteers reduced until no one was doing any gardening.

Our job a few weeks ago was to remove the roses and clear the whole place out.

No thought had been given to this sorry episode at the time of its establishment.

I fear the same now applies to the current fashion of building or making cycleways and walkways all over the countryside. Much of the basis for the activity is the belief that increasing numbers of people will be walking and cycling all over the place. That's an assumption which has logical basis. Society is simply not going to give up the use of

cars for transport. We see at the Tamahere shopping centre totally filled car parks. I think the designers were also infected with this belief that people will be walking and cycling to the centre - and if they don't, we (the designers) will force them to by not having car parking. Thats just dumb - the shoppers will go elsewhere.

#### Comments:

#### Introduction

Predator Free Tamahere ('PFT') thanks Waikato District Council ('Council') for the opportunity to make a submission on the proposed targeted rate for the Tamahere Gully Network Restoration.

PFT was established in mid-2022 by a group of enthusiastic Tamahere residents who saw the negative impact that pest animals (namely possums, rats and mustelids) were having on the flora and fauna in Tamahere. To date, 286 traps have been distributed or signed up in the PFT focus area. As a result of the significant community effort, over 1000 pest animals have been removed from the local ecosystem.

The Tamahere gully system has significant ecological, social and cultural potential. This submission outlines PFT's in principle support for the restoration of Tamahere gullies, and provides some commentary on some of the concerns with the proposed targeted rate. PFT is confident that these concerns can be constructively addressed, and that the efforts to continue the restoration of the Tamahere gully network will result in positive impacts for people and nature alike.

If there are hearings held as part of the proposed targeted rate, Predator Free Tamahere would appreciate the opportunity to speak in support of our submission.

#### **In principle support for restoration of the Tamahere gullies**

PFT recognises the significant and sustained work of the Tamahere Mangaone Restoration Trust ('TMRT') over the years. In particular, PFT acknowledges the efforts of Leo Koppens, who has worked tirelessly to improve the Tamahere gully network. PFT also supports the eco-sourcing approach which TMRT takes in their restoration.

PFT is, in principle, supportive of the ecological restoration of the Tamahere gullies. However, the information provided to the community on the proposed targeted rate did not address some aspects of the detail required to provide unconditional support for its implementation. These aspects are addressed below.

#### **Decision-making process on the proposed targeted rate**

PFT is concerned that there is a low level of awareness on the proposed targeted rate consultation in the Tamahere community. While information has been provided on Council's website, PFT notes that, to date, there has not been any correspondence with the Tamahere households to inform them about the potential targeted rate. It is PFT's expectation that additional effort be made to communicate with the Tamahere community through a range of channels regarding a potential increase to their rates bill.

### **Governance, accountability and transparency**

As previously mentioned, PFT is supportive in principle of a targeted rate to continue the restoration of gullies in Tamahere. However, PFT considers that there is not enough detail currently provided regarding the governance and accountability to provide unconditional support for the proposed targeted rate.

In particular, PFT expects that additional information be provided to the community on the following issues on the proposed targeted rate before Council makes a decision:

- Will the targeted rate funds be held by Council, the Tamahere Community Committee or the TMRT?
- What is the governance structure for managing the targeted rate? If contracted services are required, who will let the contract and manage its completion?
- What are the accountability mechanisms in place for reporting on spending and progress on the restoration outcomes? How often will this reporting be undertaken?
- What long-term protection mechanisms (such as covenants) will be implemented to protect the restoration once it is completed?
- How will the restoration of a gully network (which includes land in both private and Council ownership) be managed to ensure good process and information for private land owners?
- What is the succession plan for TRMT?

### **Ecological aspects of the restoration work**

While the restoration undertaken by TMRT to date has resulted in a significant improvement to biodiversity in the area, PFT is of the view that an ecological restoration plan be developed by appropriately qualified experts to ensure future restoration of the area results in maximum biodiversity benefits.

For example, PFT understands that bats are present within the Tamahere gully system and that some of these roost in the large trees which are present. As part of the gully restoration, PFT requests that Council ensures that large trees (whether exotic or native) within the gully network would remain as bat habitat and that this features in the ecological restoration plan. Additionally, PFT would like to see this restoration plan ensures that planting to increase food sources for birds is included.

PFT considers that pest management is a critical aspect of gully restoration. PFT would like to see pest management included in the restoration plan, and would welcome the opportunity to work with Council and TMRT on this issue.

### **Treaty obligations/responsibility to engage with mana whenua**

The expanded restoration of the Tamahere gully network presents an ideal opportunity to work with mana whenua on improving te taiao (the environment). PFT notes that the Vision and Strategy (Schedule 2, Waikato-Tainui Raupatu Claims (Waikato River) Settlement Act 2010) is the primary direction setting document for the Waikato River (including all its tributaries). Council has a range of legal obligations to engage with Māori, whether it be on decision-making or the management of environmental resources.

There are a number of the objectives and strategies in the Vision and Strategy for the Waikato River which are relevant to the restoration of Tamahere gullies. In addition, there are a iwi and hapū environmental management plans which detail the aspirations of Māori to improve te taiao.

It is unclear from the current information provided on the proposed targeted rate as to how Council and the TMRT will work with mana whenua to restore the Tamahere gullies.

PFT expects that, should they choose to be, mana whenua will be involved in all governance, planning and operational aspects of the restoration of the Tamahere gullies. Weaving together Te Ao Māori (the Māori world) and European values regarding ecological restoration in the Tamahere gully network presents an opportunity to create a richer, more diverse story about our history and our future.

**The walkway project**

The current information provided on the proposed targeted rate notes that ‘the Tamahere walkway project, funded in the 2021-2031 Long Term Plan over multiple years, would also be able to be completed earlier than anticipated’. PFT would like clarification if the proposed targeted rate will be used to fund the completion of the walkways. If this is the case, this will potentially negatively impact on the pace at which the ecological restoration of the Tamahere gully network can be completed.
