#### I. EXECUTIVE SUMMARY

The purpose of this report is to provide the Ngaruawahia Community Board (NCB) with:

- I. The Youth Action Group's Quarterly Report (prepared by Wirihana Eriepa, the Youth Action Group Representative on the Community Board).
- 2. An update from Council's Youth Engagement Advisor, Shannon Kelly.

#### 2. RECOMMENDATION

#### 3. YOUTH ENGAGEMENT IN NGARUAWAHIA

Snapshot of Youth Engagement and Youth Action Group work in Ngaruawahia community:

- March 2016: Youth Engagement Advisor organises local youth consultation for the Waikato District Youth Awards 2016 with Ngaruawahia High School.
- April 2016: Youth Engagement Advisor establishes the Ngaruawahia Youth Action Group. Antonia Van den Bemd is nominated by group as interim Youth Action Group Co-ordinator.
- April 2016: Wirihana Eriepa and Antonia Van den Bemd participate as youth judges of Waikato District Council Youth Awards 2016.

- May 2016: Ngaruawahia Youth Action Group is established.
- June 2016: Antonia Van den Bemd is recognised by the Ngaruawahia Community Board as the interim Youth Action Group Co-ordinator and attends her first meeting. James Whetu agrees to be Youth Mentor.
- July September 2016: Youth Action Group Coordinator sets up, facilitates and plans monthly meetings with youth in Ngaruawahia. Youth Engagement Advisor provides administration, capacity support, food, resources and supervision until Coordinator is set up.
- October / November 2016 Wirihana Eriepa joins Ngaruawahia Community Board as Youth Representative.
- September 2016 February 2017: Embrace The Future work on development of Frame Your Town project, with support of Council staff (the Parks and Reserves team, Sheryl Paekau (Policy Planner), Marae Tukere (lwi and Community Partnership Manager), Lianne Van den Bemd (Community Development Advisor), Betty Connelly (Senior Planner), I-Jay Huirama (Community Engagement Administrator) and Shannon Kelly and Ngaruawahia Community Board members.

Issues and projects discussed in groups since May last year:

- New name for Ngaruawahia Youth Action Group complete.
- Facebook set up complete.
- Frame Your Town Community Project in progress.
- Local Youth Hub available involved in conversations and consultation regarding a community facility in Ngaruawahia.

Both youth representatives have been actively involved in the Community Board discussions and have been given speaking rights by the Community Board.

#### 4. GOVERN UP PROGRAMME

In January 2017 Waikato District Council successfully applied to the Ministry of Youth Development for funding to establish mentoring positions and Youth Action Groups for young people. Ngaruawahia was one of the towns that funding was approved for.

Govern Up is a programme that will allow young people in Ngaruawahia to join the Ngaruawahia Youth Action groups, develop and use leadership skills and participate in youth led and initiated projects / events. Young people in leadership positions will support and mentor other young people and the Ngaruawahia Youth Action Group will recruit young people from their towns.

Young people in the Youth Action Groups will have a budget of \$500-\$1000 to spend on youth development and community based projects for Ngaruawahia that they design. The projects are required to be youth coordinated and youth planned, and the projects will have to be completed by 30 June 2017.

We are asking for the Ngaruawahia Community Board to support the development of the Govern Up project by supporting the youth involved in these projects. It is envisioned that the Ngaruawahia Community Board support the youth groups to plan and execute the programmes as young people ask for assistance.

In order for this programme to be successful, we need at least 60 young people from across the district to participate in this project. We are hoping to have at least 10-15 of those young people come from the Ngaruawahia projects. We also need a dedicated adult agency / individual / mentor to support the youth group as they are developing their projects, and to liaise with Council's Youth Engagement Advisor.

The responsibilities will be:

- To follow up with the Youth Action Group.
- To help the group progress their projects forward.
- To help the group maintain momentum of their projects.
- Liaise with the Youth Engagement Advisor regarding progress and projects.

The Youth Engagement Advisor has been in contact with the Community Board Youth Mentor to discuss the best way forward and suggestions to support and promote positive youth participation through the Community Board meetings.

#### I. EXECUTIVE SUMMARY

E ngaa mana, e ngaa reo, e ngaa rangatira maa, teenaa koutou katoa.

This is my first Chairperson report, and hopefully it continues hereon. It is my ambitious intent to have a report included in every Ngaaruawaahia Community Board (hereon NCB) agenda to outline the activities of the NCB between our monthly meetings.

Concerns raised by community groups/ratepayers:

## NGAARUAWAAHIA PRIORITY PROJECTS - CONSULTATION WITH NGAARUAWAAHIA COMMUNITY

The NCB initiated consultation with the Ngaaruawaahia community via social media and posters in February starting 15<sup>th</sup> of February and finishing on the 24<sup>th</sup> of February (nine days later).

The short time frame was reflective of the small window between NCB workshops and the closing date for Long Term Plan (hereon LTP) priority projects to be submitted to Council staff.

Feedback was sought from the community on the four LTP priority projects identified by the NCB. The engagement document sent out via social media, email and as posters to the community is attached to this report. The document requested that community members rank the four projects from I (favourite) to 4 (less favourite).

Comments on Facebook, emails sent to the Chairperson, and pamphlets dropped in the drop box at the Community House were received. In total, 44 community members promptly responded to the request.

Of the four LTP priority projects, the top ranked project was to **Transform Te Mana o Te Rangi Reserve**. At second was **create a doorway(s) into Ngaaruawaahia by enhancing our entrances.** Accordingly, these two projects will be submitted to Council staff for consideration in the LTP.

It is important to note that of the 44 respondents, 17 emails were received on a project that was not identified as an NCB priority project. This proposed project was the development of an aquatic and indoor sports complex on Patterson Park. It was outlined in the emails that this project was identified as a result of the consultation with community during the community multipurpose facility discussion.

It is the view of the Chairperson that although a substantial number of respondents were for the aquatic and indoor sports complex, the initial request and direction to the community was on the four priority projects, not to propose new projects. It would be unfair to adopt a project that was not part of the wider community discussion. However what it has highlighted though is that a review of the 2009 Ngaaruawaahia Community Plan should be consider by this NCB as an NCB initiative so that projects such as proposed and supported by the 17 respondents Is not lost and that a wider strategic and wider community discussion can be had.

#### MANA WHENUA IN NGAARUAWAAHIA - NGAATI TAMAINUPO

During consultation with the community on the four priority projects for Ngaaruawaahia, mana whenua representatives of Ngaati Tamainupo made contact and advised their support on the project to transform Te Mana o Te Rangi reserve.

Ngaati Tamainupo have expressed an interest in taking part in the planning of this project as one of the mana whenua groups for Ngaaruawaahia, and have requested an opportunity to present to the NCB. I have suggested that I will arrange their attendance and presentation to the NCB at its May meeting would be provided.

## COMMUNITY BOARDS COMMENTS ON NGAARUAWAAHIA STRUCTURE PLAN

NCB comments were fed back to Council staff. Thank you to everyone who provided comment, especially Kiri Morgan for identifying typos and misspelt Maaori words and ensuring consistency of their use through the document.

#### **NGAARUAWAAHIA YOUTH ACTION GROUP**

I meet with Shannon Kelly, Council's Youth Engagement Advisor, to gauge and understand her views of the opportunities and challenges for the Ngaaruawaahia Youth Action Group. In recognition of the challenges the group faces, I have requested from Shannon a tentative budget to indicate likely costs to operate a well functioning and empowered Ngaaruawaahia Youth Group.

It is anticipated that this will be shared with the NCB at our April workshop.

#### EASTER POLICY AND NATURAL PARKS RESERVE MANAGEMENT PLAN

Submission period for these closed on the  $17^{th}$  of February and  $3^{rd}$  of March respectively. Hopefully NCB members who wished to have a view, provided feedback to Council.

# WE NEED YOUR FEEDBACK USE YOUR VOICE TO MAKE A CHANGE

The Ngaaruawaahia Community Board have the privilege of representing the Ngaaruawaahia community by having direct dialogue with the Council staff and Governors regarding a number of Council business and service lines.

For this particular paanui, we are seeking feedback and support from the Ngaaruawaahia community on priority projects we have identified for our community.

We have been asked by Council to identify our priority projects so that they are considered as part of the Long Term Plan (LTP) 2018 – 2028. What is the LTP? In brief, the purpose of the LTP is to set the budgets and projects for Council over the next 10 years.

To frame our priority projects for this LTP, the Ngaaruawaahia Community Board have used the 2009 Ngaaruawaahia Community Plan to frame two objectives:

- 1. Improve the visual appeal of Ngaaruawaahia that is inspired by its environment, culture, heritage, and history
- 2. Support the wellbeing of our community help our people (including our young people) to succeed

After considerable discussion, the Ngaaruawaahia Community Board are proposing the following priority projects to be considered by Council, with the indication that one or two will be adopted in the LTP 2018 - 2028.

These priority projects are:

# > Transform Te Mana o Te Rangi reserve through beautification and to enable community use for recreational purposes

Often referred to as the "old dump site", the Ngaaruawaahia Community Board have identified this project as their number one priority project. The Ngaaruawaahia

Community Plan 2009 also identifies this project as a project to pursue.

It is anticipated that this project will be a project of significance to our community, so we are proposing that appropriate community engagement is applied in the development of plans to transform Te Mana o Te Rangi reserve.

The Ngaaruawaahia Community Board are also anticipating that partnerships will need to be forged within the community and district to achieve this project.



- Localised programmes and initiatives that improve community understanding on:
  - a. waste minimisation activities directed by the Council to community, and
  - b. residential water management directives from Council on homeowners/occupiers

With the Waikato and Waipaa Rivers encompassing our town, and the Hakarimata ranges overlooking the community, the NCB acknowledge that we have a responsibility to look after our environment. We wish to see Council to do more to improve our understanding



of initiatives that aim to look after our environment. Localised programmes and initiatives, tailor-made for Ngaaruaawahia, is a measure the Board considers a good start.

#### Restore and repurpose the Old Flour Mill

Ngaaruawaahia has a story and a number of historical buildings and features that is part of that story. The Old Flour Mill had been established in 1871 at the confluence of the



Waikato and Waipaa Rivers to grind wheat and other grains produced by Maaori and other farmers. The building is of considerable historical value and is the only standing remnant of one the most important colonial flour mills in the Waikato.

The Ngaaruawaahia Community Board anticipates that the project will need to involve Heritage New Zealand and for partnerships to be forged within the community and wider district to achieve this project.

Create a doorway into Ngaaruawaahia by enhancing our main entrance through distinctive artwork that reflects our surrounding environment, culture, and heritage

The Ngaaruawaahia Community Board would like to improve our main entrance way into

Ngaaruawaahia by displaying a signature piece of artwork that is distinctively Ngaaruawahia. We have seen the positive impact and value that the entrance (tomokanga) for the Haakarimata walkway has had on the community, our Ngaaruawaahia whaanau who have gone abroad, and our visitors to the Haakarimata walkway.
