Meeting held 15/11/16 to discuss top ten ideas for Pokeno resulting from recent workshop

Apologies: Wayne Rodgers, Lance Straker

The members present considered the following ideas the most important.

1 Toilets

An upgrade of the toilet block. That there should be consistent opening time, it was reported that at times it wasn't open at 9.30am

2 Public Transport to Pukekohe and Auckland

Although trains were considered to be the ideal solution it was realised that this may be a long time coming. An interim solution was proposed that there should be regular transport to coincide with the trains in Pukekohe – this could be a shuttle bus that left every hour to coincide with the arrival and departure of every second train. It would serve also as a shopping bus to Pukekohe.

3 Sports and Recreation

The need for open spaces in the area. What is happening? Where are they? How are they being developed?

4 Emergency Services

The need for a location for fire, ambulance and Civil Defence in Pokeno.

5 Footpaths

These need to be developed for safer walking around Pokeno.

6 Ford Street

The closure of Ford Street so it is no longer a short cut for trucks. It was suggested that an open space for our community be developed to replace the proposed loss of the berm along Pokeno Road which will occur with the proposed new overbridge and road exit into Pokeno Road from the Hitchen Block.

9 Getting the trucks out of the main road

Report Title	Pokeno Street Lighting Oclyte Investigation

I. EXECUTIVE SUMMARY

We received a request for an oclyte to be installed on main street lighting at the Pokeno Open Day from a member of the Pokeno community.

There are two types of street lighting in Pokeno:

- 1. Standard lighting shearbase style, 2mm base thickness located on either side of the main business precinct previous 'S.H.1' road lighting.
- 2. Non-standard lighting Cast iron/steel variation located along Great South Road along the main business precinct road.

A suitable base thickness to support the weight of flags/banners is 4mm-5mm (currently used by Auckland Council). The structural strength of the current standard street lighting is inadequate to support the weight of additional hardware and may compromise the IP rating if any additional hardware was to be added to the current street lighting.

The non-standard street lighting mode of failure is different to that of standard street lighting. Due to the rarity of replacement parts, and the lack of information available as to maximum wind loading conditions, installing additional hardware would not be recommended. Where an oclyte would gradually buckle under additional loading, these would fail as a result of repetitive flexing and could form hidden (to the naked eye) stress cracks which could result in what we call catastrophic failure. *Effectively the light could be standing straight up one minute and on the ground next minute with no warning of impending failure*.

As can be appreciated, this poses significant safety issues and especially when there are often large numbers of people gathered in this area waiting to get their ice creams.

We have commenced a district wide pole testing programme and have started in our coastal zones and will move to the area surrounding the Huntly Power station due to the corrosive effects of the wind borne coal dust in the area.

We hope to have checked every aged or "condition unknown" pole within the next I2 months to give us a better picture of what we are facing with regards to a pole replacement programme but more importantly, to ensure that our ratepayers and/or roadusers are not exposed to risk from a dedicated streetlight pole failing without warning.

As a result of our investigation, the current standard and non-standard street lighting options located in Pokeno would not be suitable for installation of an oclyte.

We recommend that future updated/replacement street lighting in Pokeno have a 4mm-5mm base requirement and an oclyte attached as per pole replacement programme needs.

Hi Karen

These are non – standard lights and are very hard to find replacement parts for.

As such, we would probably be even more reluctant to install additional hardware as we have no information available as to the maximum windloading allowable on these assets.

Without doing a site investigation, these lights appear to be made of cast iron/steel so the mode of failure is different from the standard oclyte.

Where an oclyte would gradually buckle under additional loading, these would fail as a result of repetitive flexing and could form hidden (to the naked eye) stress cracks which could result in what we call catastrophic failure.

Effectively the light could be standing straight up one minute and on the ground next minute with no warning of impending failure.

As can be appreciated, this poses significant safety issues and especially when there are often large numbers of people gathered in this area waiting to get their ice creams.



We have commenced a district wide pole testing programme and have

started in our coastal zones and will move to the area surrounding the Huntly Power station due to the corrosive effects of the wind borne coal dust in the area.

We hope to have checked every aged or "condition unknown" pole within the next 12 months to give us a better picture of what we are facing with regards to a pole replacement programme but more importantly, to ensure that our ratepayers and/or roadusers are not exposed to risk from a dedicated streetlight pole failing without warning.

Hi Karen, Please see the response from my Street Lighting Project Manager. Essentially, the light poles in Pokeno do not have the required structural strength for us to attach any further hardware to them.

As such, there is no process to follow as we would not approve the installation of these outrigger poles.

I realise that this is not the response the community would be hoping for but we need to protect our (the ratepayers) assets and cannot compromise safety of the road user or general public.

Hi Peter,

I agree that I would also be reluctant to hang banners / flags on existing street light poles as we could compromise the IP rating of the poles as far as wind loading especially if the street light pole is a shearbase style like the ones shown in the picture below?

I have not had any involvement with installing flags on street light poles in my history of street lighting?

I know that Auckland Council have to install street light poles with 4mm-5mm thick metal base sections to allow these street lights to carry flags/ banners.

Please note that the street light poles in Pokeno with only have 2mm thick bases,

Personally I would be reluctant to attach anything to our asset as we could compromise the IP rating of the pole as far as wind loading goes and we have no way of knowing who will be doing the flag placement work as it is not core business for us.
