Council Roading

- It is felt that the new alignment of the corner of Munroe and Helenslee Road creates a safety issue. You almost need to stop to go around it
- With the opening of the Hitchen Bridge cars and more importantly trucks(using it as a short are using Mark Ball Drive and Hillpark Rd. There is a 40km/h sign at either end but this is not being obeyed. If this is observed this should be reported to the police. This is a policing issue and Mayor Sanson is to talk to the District Commander to get the traffic police to take an interest in the problem. It was suggested that we get the police back to a meeting
- The 40km/h signs have not yet gone up in Avon Rd
- It was asked about the possibility of a Give Way sign at the corner of Fraser Rd and Dean Rd. This is where the turn off to Kowhai Downs is and residents would like a light here

- We are wanting an update on the speed bylaw changes for Helenslee Rd as our 40km/h school zone can't be moved to its correct location until this is passed. This in turn is holding us up being able to use the Kea Crossing on Helenslee Rd

Community Project Update


Parks

Munro Road Sportspark

Procurement planning has recommenced following receipt of the draft Flood Risk Assessment Memorandum produced by Opus. This states that development of Munro block would not have significant effects on the surrounding areas and that the current design will have minimal flooding in areas vulnerable to silt deposits.

The earthworks required to provide a platform to a mowable finish will be carried out in a staged process.

- Stage I will see the construction of the new two stage stream alignment and establish grass and riparian planting. Temporary watercourse dams will be constructed and sump pump to drain water trapped during establishment of vegetation.
- Stage 2A is for the cut/fill levelling between the existing stream and new diversion.
- Stage 2B is for filling of the top section (and a minor cut area). This portion will require imported fill and is being considered as a clean fill site to reduce the overall cost of the project.
- Stage 3 is for removal of the watercourse dams and pump system to make the new stream live. This stage will also allow us to fill the existing stream.



Timeframes for stages 1 to 3 are being assessed and will be reported on throughout the project life.

Wastewater

Pokeno Wastewater Reticulation Scheme, Phase 3

The contract is to be advertised soon for the completion of the private drainage connections in Pokeno. Staff are awaiting the availability of the archaeologist to oversee the works. Onsite inspections have been carried out with potential contractors to enable effective pricing. We expect quotes to be received shortly.

Toilets

Pokeno, The Point, Ngaruawahia and the Domain, Tuakau

Contract document preparation is well underway for this Toilet Refurbishments package. The procurement process has begun.

Urban Upgrades

Pokeno Road Urban Upgrade

Undergrounding by Counties Power on Pokeno Road and Great South Road is nearing completion. Some further works are expected undergounding and removing existing power poles on the eastern side of Munro Road and installing new buried cables from the one lane bridge, past the future sports park, to Pokeno Road intersection. This will enable widening and upgrading of the road alongside the sports park, a future Urban Upgrade project site.

The first Urban Upgrade section to get underway runs from outside the school on Pokeno Road to the intersection with Great South Road. With the overhead cables gone, the way is clear for next summer's works. This will include footpath, cycleway, streetlights, and signalised intersections at both Helenslee and Hitchen Road intersections.

Cemeteries

Whangarata Road Cemetery

The design for consent has been lodged for assessment and is currently being reviewed. Consent on the current design was lodged within Council as there is a pending District Plan review which if passed will see the status for the construction of Cemeteries heightened from "Controlled Activity" to "Discretionary Activity" meaning that all previous consultation will be invalidated, and there is the potential for Discretionary Activities to be declined completely.

It has been noted that further consultation may be required however staff do not feel this will affect Stage I of the cemetery construction. Consultation is believed to be targeted at types and locations of burial plots which has no effect on consents, as well as the possibility of a future privately owned crematorium. Crematoriums are not part of Council's strategic planning and operations and would only be undertaken by a private investor. Consent to operate such a facility will therefore require the private investor to obtain their own consent and consideration of location agreed with Council. This may be carried out under the future Stage II.

Council staff have undertaken road widening and safety improvements of this intersection in conjunction with the Waikato District Alliance (WDA) rehabilitation works on a cost share basis. This was to

reduce the overall cost to the cemetery project and minimise the risk of later re-work being required. Some minor changes to the linemarking layout may be required pending consent conditions, however this will coincide with the WDA reseal programme during their scheduled second coat seal.

Please see the updates below on matters arising from the Pokeno Community Committee:

Double Yellow lines

Council staff engaged a contractor to look at the corner of Helenslee Road.

Double yellow lines were painted on the corner of Helenslee Road in mid May 2019.

In addition, a survey of the road boundary was undertaken to see if any of the trees were on the road boundary. The four trees on the corner are on private property and there are three trees on road reserve which stand before the corner. Council staff can have these trees trimmed but will need to have a discussion with the private land owner about the others.

Munro Sport fields

Council has taken advice from Opus with regards to the sport fields and based on the draft report, construction of the design by Harrison and Grierson will have no significant impact on the stormwater management in the catchment.

There will be three stages:

- I. Stage I will be the stripping back of the topsoil and stockpiling it, construct the new stream alignment.
- 2. Stage 2a will see the completion of the higher area that will house the netball, basketball, artificial turf and clubrooms.
- 3. Stage 2B will take some time as there needs to be additional soil imported in for the establishment of the sport fields.


