# I. EXECUTIVE SUMMARY

At the inaugural meeting the Community Committee is required to appoint a Chairperson, a Deputy Chairperson and Secretary.

Community Committee members and Councillors are eligible to stand for the role of Chairperson and a member can vote for themselves provided there is a seconder.

The Committee must comprise between 5 and 12 elected members in accordance with the Committee Charter. Therefore, if there are 13 people for the 12 positions, people will be asked to vote for the 12 positions by writing down the names of the nominee they are voting for. These will be collected and counted.

The Community Committee also appoints a secretary for taking of minutes and attending to other administrative matters on behalf of the Committee.

Funding is in place from the LTP with \$1,000,000 the first year, \$500,000 the second and \$1,500,000 the third
