Public Forum
Agenda Item 5

## <u>Discretionary Fund Report to 30 June 2019</u> Agenda Item 6.1

The report was received [NCB1909/02 refers]. The following items were discussed:

- Ngaruawahia Railway Bridge commitment
  - Cr Patterson updated the Board on the increased interest in pools. An invoice from Belgravia Leisure (\$1630 + GST) was expected, which would be paid from this commitment.
  - Cr Gibb noted that donations and other contributors funded the recent memorial planting.
- Horotiu Playcentre and Graeme Dingle Foundation Waikato invoices had still not been received.

Mr Sherson joined the meeting (6:10pm) during discussion on the above item.

## Ngaruawahia Works and Issues Report

Agenda Item 6.2

The report was received [NCB1909/02 refers].

The following items were discussed:

• Playground equipment at the Point – Whatawhata community declined the opportunity to take the surplus equipment, following a recent Council resolution. It is proposed it would be gifted to the Ngaruawahia Christian Youth Camp.

• Cenotaph vandalism – work ongoing to source suitable stone and organise installation.

## Ngaruawahia Community Board Resolution/Action Register Agenda Item 6.3

The report was received [NCB19009/02 refers] and the following items were discussed:

- Te Mana o Te Rangi Reserve new signs for the Reserve would be installed in November.
- The Point (photo frame) the new Community Board after the elections could consider this matter as part of the Council's Youth Engagement Plan.

## ACTION: Cr Gibb to follow up with Cory on this project.

- The Point the Reserve Management Plan had been adopted by the Council.
- Recycling bins at The Point would be considered as part of the Council's Solid Waste Review in 2020.
- The Point (change of name) whether the name should be changed to Te Huinga o Ngaa Wai or for there to be bilingual signage could be considered as part of the public consultation that would be required.

- Community's response to the tragedy at the rail bridge;
