REPORTS

Raglan Holiday Park Papahua Governance Board Item 6.1

The report was received under [INF2209/01] and the following discussion was held:

- Why had revenue declined given the Covid payment and why were there fewer visitor and employees but higher costs? Work was put into resourcing and increasing security which has resulted in more staff on the books. The living wage was also introduced which increased the cost of the operating services.
- With the increases in operating costs and revenue halved will this impact the Camp's
 financial position? The financials for the Camp were healthy considering the downturn in
 tourism over the past couple of years.
- Reinvestment of profits The Board had briefly considered what to do with the profits for Hapu and the wider community but it was yet to be decided on. The Board has been considering a retreat management plan, there is also a capital work programme and the ongoing perimeter fence development.
- A discussion was held around co-governance and partnership with Ngati Mahanga.
- Concern was raised around how Council can support people struggling to find housing in Raglan. Lease holders at the camp can only stay 80 days in a calendar year but no consecutively. There is also the Whanau campground for homeless people in Raglan. Cr Thomson commented that the Board needed to look at the issue of homelessness as part of their Strategic Direction.

<u>Service Delivery Project Status Report – September 2022</u> Item 6.2

The report was received under [INF2209/01] and taken as read. The following discussion was held:

- Concern was raised around roading project design, monitoring and sign off.
- Concern was raised around how Council was tracking in terms of project delivery.

- Dog Pound There was a proposal to build a centralised dog pound in Huntly and there will be a smaller facility in Tuakau. The Ngaruawahia site will likely be wound down or no longer required. Originally the Ngaruawahia site was to be upgraded to improve safety but that work was being held off. A site on Old Taupiri Road for the centralised Dog Pound was considered but deem unsuitable due to development in the area.
- Kiwirail building Moving the Kiwirail building had been delayed due to an additional consent being required that Council was not aware of.
- A discussion was held around the challenges that the future Council face with roading projects and the Long Term Plan.
- Concern was raised about the World Rally Championship Memorendum of Understanding.

<u>Proposed Extension to Leased area Raglan Surf Lifesaving Club, Raglan Item 6.3</u>

The report was received under [INF2209/01] and taken as read and no discussion was held:

Resolved: (Cr Smith/Cr Thompson)

THAT the Infrastructure Committee recommends that Council:

- a. pursuant to Section 54 of the Reserves Act 1977 Council exercises its delegated authority as Lessor, to grant an extension of the Raglan Surf Life Saving Club Incorporated leased area to include an additional area of approximately 82 square metres, to enable the extension of their building to provide a new control room and deck, being part of Lot 1 DPS 44506, subject to, the applicant:
 - i. continuing engagement with hapū regarding the proposal and the planting of the reserve and leased area.
 - ii. obtaining any required resource and building consents to undertake the construction.
 - iii. executing a Deed of Lease variation to record the amended lease area.
- b. the Applicant is to meet all costs incurred through the process; and
- c. the Chief Executive being satisfied as to the hapū engagement, he is delegated authority to execute all relevant documentation to give effect to the resolution.

Alfred Main Drive – Land Review Item 6.4

The report was received [INF2209/01] and taken as read. The following discussion was held:

- The parcel of land was acquired under the Public Works Act for a road. The road
 was longer being built and land was now surplus to requirements. Under the Public
 Works Act the Council had a legal obligation to offer and sell the land back to the
 previous landowners unless it can prove it will be used for another public works
 project.
- Concern was raised that the local Ward Councilor and Community Committee was not consulted given the land was in an area where there was expected to be growth.
- What was the land worth? As the process to sell the land had not started there was no formal evaluation but it is expected to be somewhere between \$1.5-2.2 million.
- Concern was raised that the money gained from the sale of the land will not directly go back into purchasing land in Tamahere.

Resolved: (Cr Smith/His Worship, the Mayor)

That the Infrastructure Committee:

- a. approves that Section 1 SO 574401 at Alfred Main Drive, Tamahere is not required in connection with the roading project, be declared surplus;
 - b. and further that when declared surplus, Section 1 SO 574401 be disposed of in accordance with the requirements of the Public Works Act 1981 and the sale proceeds be applied to the Property Proceeds Reserve;
 - and further that should the former owner not accept the offer to purchase, that Section 1 SO 574401 be available for sale on the open market in accordance with the Council's Strategic Land Acquisition and Disposal Policy; and
 - d. delegates to the Chief Executive the authority to execute all relevant documentation to give effect to these resolutions.

 - b. the applicants are to meet all costs incurred through the process;
 - c. execution of the easement agreement shall be subject to consultation with iwi and hapū, provided that the Chief Executive retains discretion to proceed where appropriate; and
 - d. the Chief Executive be delegated authority to execute all relevant documentation to give effect to the resolution.

- a. proceeds to notify the proposal to stop a portion of formed Martin Lane, Horsham Downs, as delineated on Attachment 1 and 2 (being approximately 1790m² (Subject to survey), in accordance with the Local Government Act 1974;
- b. if no objections are received during public notification or are withdrawn thereafter, the road stopping process continues and the portion of road described as 'proposed road to be stopped' on Attachment 1 be declared to be stopped in accordance with the Local Government Act 1974;
- c. the section of land resulting from the road stopping action be transferred for amalgamation with Lot 1 DPS 76724 and Section 4-5 SO 500297 and Lot 1 DP 504278, forming title 773527, at a price established by registered valuation, along with access to at least 20 carparks for school /public use;
- d. should the road stopping proceed that Council acquires for road by part exchange that portion of land described as 'Section 2' and 'Section 3' on Attachment 3 being approximately 92m² combined (subject to survey), by way of offset from the road to be stopped at a price to be determined by registered valuation;
- e. the net proceeds of sale be credited to the Property Proceeds Reserve; and
- f. the Chief Executive be delegated authority to execute all relevant documentation to give effect to this resolution.
