1. Havelock Village Limited (**HVL**) wishes to be a party to the following proceedings under s 274 of the Resource Management Act 1991 (**RMA**):

Hopkins v Waikato District Council (ENV-2022-AKL-000090)

2. The proceedings concern an appeal lodged by Patricia (Teresa) Ellen Hopkins and Steven Paul Treyton Hopkins (together, **Hopkins**) against a decision of Waikato District Council (**Council**) on the Proposed Waikato District Plan (**PWDP**) to partially rezone the land owned by the Hynds Foundation at 62 Bluff Road, Pokeno for Heavy Industry, which was publicly notified on 17 January 2022 (**Decision**).

Nature of interest in the proceedings

3. HVL owns significant landholdings in the southern Pokeno area, at 88, 242 (in part), 5 Yashili Drive and 278 Bluff Road (the **Site**). As part of its planned developments in Pokeno, HVL is seeking to develop the Site to enable a comprehensive and integrated residential development.
4. HVL made a further submission about the subject matter of the proceedings. HVL has also lodged its own appeal (*Havelock Village Limited v Waikato District Council* (ENV-2022-AKL-000072)) on the subject matter of the appeal.

Extent of interest in the proceedings

5. HVL is interested in all of the proceedings that relate to the rezoning of additional land owned by the Hynds Foundation for Heavy Industry at 62 Bluff Road.
6. HVL supports the relief sought in the appeal to the extent it is consistent with its own appeal, for the reasons outlined in its own appeal.

Alternative dispute resolution

7. HVL agrees to participate in mediation or other alternative dispute resolution of the proceedings.

Note to person wishing to be a party

You must lodge the original and one copy of this notice with the Environment Court within 15 working days after:

- (a) the period for lodging a notice of appeal ends, if the proceedings are an appeal; or
- (b) the decision to hold an inquiry, if the proceedings are an inquiry; or
- (c) the proceedings are commenced, in any other case.

Your right to be a party to the proceedings in the court may be limited by the trade competition provisions in section 274(1) and Part 11A of the Resource Management Act 1991.

The notice must be signed by you or on your behalf.

You must serve a copy of this notice on the relevant local authority and the person who commenced the proceedings within the same 15 working day period and serve copies of this notice on all other parties within 5 working days after that period ends.

However, you may apply to the Environment Court under section 281 of the Resource Management Act 1991 for a waiver of the above timing or service requirements (see form 38).
