# NOTICE OF HYNDS PIPE SYSTEMS LIMITED AND THE HYNDS FOUNDATION WISH TO BE PARTY TO AN APPEAL

- 1. Hynds Pipe Systems Limited and the Hynds Foundation (together, Hynds) wish to be a party to Fonterra Co-Operative Group Limited (Fonterra)'s appeal (Appeal) in respect of the Waikato District Council (Council)'s decisions on the Proposed Waikato District Plan (PWDP). The Appeal has the Environment Court reference number ENV-2022-AKL-000042.
- **2.** Hynds made submissions about the subject matter of the proceedings. In particular:
  - (a) Hynds Pipe Systems Limited made a submission on the PWDP; and
  - (b) Hynds Pipe Systems Limited<sup>2</sup> and the Hynds Foundation<sup>3</sup> made further submissions on the PWDP, including in relation to reverse sensitivity issues.
- **3.** Hynds is not a trade competitor for the purposes of sections 308C or 308D of the Act.
- **4.** Hynds is interested in the parts of the Appeal that relate to reverse sensitivity issues.
- **5.** Hynds is interested in the following particular issues raised by the Appeal:
  - (a) the relief sought in respect of Policy GRUZ-P13; and
  - (b) the insertion into the PWDP of a definition of "Reverse Sensitivity".
- **6.** Hynds supports the intent of the relief sought in respect of reverse sensitivity effects because:
  - (a) Hynds operates a regionally significant precast concrete manufacturing and distribution plant within the strategic industrial node at 9 McDonald Road, Pokeno (Hynds Factory Site).

- (b) Hynds' primary interest in the PWDP is ensuring that its operations are protected from reverse sensitivity effects. Hynds wants to ensure that its ability to carry on its business, or expand its operations (including obtaining the necessary resource consents) is not limited by the constraints that would necessarily arise as a result of sensitive land uses (including residential activities) establishing in proximity to the Hynds Factory Site.
- (c) While Hynds supports the intent of the amendments to the PWDP sought in the Appeal, it considers that further amendments may be required to appropriately address reverse sensitivity effects on heavy industrial operations such as its own.
- (d) Hynds' own appeal against the PWDP<sup>4</sup> also seeks amendments to Policy GRUZ-P13, as well as other provisions relating to reverse sensitivity effects.
- **7.** Hynds agrees to participate in mediation or other alternative dispute resolution of the proceedings.
