## Chapter 17: Business Zone

- (1) The rules that apply to activities in the Business Zone are contained in **Rule 17.1** Land Use – Activities, **Rule 17.2** Land Use – Effects and **Rule 17.3** Land Use – Building.
- (2) The rules that apply to subdivision in the Business zone are contained in **Rule 17.4**.
- (3) The activity status tables and standards in the following chapters also apply to activities in the Business Zone:
  - 14 Infrastructure and Energy;
  - 15 Natural Hazards and Climate Change (Placeholder).
- (4) The following symbols are used in the tables:
  - (a) PR Prohibited activity
  - (b) P Permitted activity
  - (c) C Controlled activity
  - (d) RD Restricted discretionary activity
  - (e) D Discretionary activity
  - (f) NC Non-complying activity
- (5) The Business Zone contains a Specific Area that is Lakeside Te Kauwhata Precinct. **Rule 17.5** manages all land use, building and subdivision in this location. **Rule 17.5.1** sets out how to apply rules to the Lakeside Te Kauwhata Precinct that are either different from, or are in addition to, other rules that apply to the rest of the Business Zone.

### 17.1 Land Use – Activities

#### 17.1.1 Prohibited Activities

- (1) The following activity is a prohibited activity. No application for resource consent for a prohibited activity can be made and a resource consent must not be granted.

PRI	Any <b>building</b> , structure, objects or vegetation that obscure the sight line of the Raglan navigation beacons for vessels entering Whaingaroa (Raglan Harbour) (refer to <b>Appendix 8</b> ).

#### 17.1.2 Permitted Activities

- (1) The following activities are permitted activities if they comply with all of the:
  - (a) Land Use – Effects rules in **Rule 17.2** and Land Use – Building rules in **Rule 17.3** (unless the activity-specific rule and/or conditions identifies a condition(s) that does not apply); and
  - (b) Activity-specific conditions.

### 17.1.4 Discretionary Activities

(1) The activities listed below are discretionary activities.

D1	Any activity that does not comply with Land Use – Effects or Land Use –Building rules, unless specified in <b>Rule 17.2 or 17.3</b> applies.
D2	Any activity that does not comply with one or more activity-specific conditions for a permitted activity under <b>Rule 17.1.2</b> .
D3	Any <b>multi-unit development</b> that does not comply with one or more conditions for a restricted discretionary activity under <b>Rule 17.1.3 RDI</b> .

### 17.1.5 Non-Complying Activities

(1) The activities below are non-complying activities.

NC1	<b>Multi-unit development</b> that does not comply with a condition for a restricted discretionary activity under <b>Rule 17.1.3(a)(iii)</b> .
NC2	<b>Residential activity</b> that does not comply with an activity-specific condition for a permitted activity under <b>Rule 17.1.2 P4</b> .
NC3	Any activity that is not listed as Prohibited, Permitted, Restricted Discretionary or Discretionary.

## 17.2 Land Use – Effects

### 17.2.1 Noise

- (1) **Rules 17.2.1.1 and 17.2.1.2** provide the permitted noise limits for noise generated by land use activities.
- (2) **Rule 17.2.1.1** Noise – general provides permitted noise limits in the Business Zone.
- (3) **Rule 17.2.1.2** Noise – Construction provides the noise limits for construction activities.

#### 17.2.1.1 Noise – General

P1	<b>Farming noise</b> , and noise generated by <b>emergency generators</b> and emergency sirens.
P2	(a) Noise measured within any <b>site</b> : <ol style="list-style-type: none"> <li>(i) In the Business Zone must not exceed:                 <ol style="list-style-type: none"> <li>A. 65dB (LAeq), 7am to 11pm every day; and</li> </ol> </li> </ol>

	<p>B. 55dB (LAeq) and 85dB (L<sub>Amax</sub>), 11pm to 7am the following day;</p> <p>(ii) In the Residential or Village Zone must not exceed:</p> <p>A. 55dB (LAeq), 7am to 7pm;</p> <p>B. 50dB (LAeq), 7pm to 10pm;</p> <p>C. 45dB (LAeq) and 75dB (L<sub>Amax</sub>), 10pm to 7am the following day.</p>

### 17.2.1.2 Noise – Construction

PI	<p>(a) Construction noise must meet the limits in <b>NZS 6803:1999 (Acoustics – Construction Noise)</b>; and</p> <p>(b) Construction noise must be measured and assessed in accordance with the requirements of <b>NZS6803:1999 'Acoustics – Construction Noise'</b>.</p>
RD1	<p>(a) Construction noise that does not comply with <b>Rule 17.2.2 P1.</b></p> <p>(b) Council's discretion is restricted to the following matters:</p> <p>(i) Effects on amenity values;</p> <p>(ii) Hours and days of construction;</p> <p>(iii) Noise levels;</p> <p>(iv) Timing and duration; and</p> <p>(v) Methods of construction.</p>

### 17.2.2 Servicing and hours of operation

PI	The loading and unloading of vehicles and the receiving of customers and deliveries associated with a <b>commercial activity</b> on a <b>site</b> adjoining the Residential and Village Zones may occur between 6.30am and 7.30pm.
RD1	<p>(a) Servicing and operation of a <b>commercial activity</b> that does not comply with <b>Rule 17.2.2 P1.</b></p> <p>(b) Council's discretion is limited to the following matters:</p> <p>(i) Effects on amenity values on <b>adjoining sites</b> within the Residential Zone and Village Zone;</p> <p>(ii) Timing, duration and frequency of adverse effects;</p> <p>(iii) Location of activity in relation to zone <b>boundary</b>;</p> <p>(iv) Location of activity in relation to <b>dwellings</b> on <b>adjoining sites</b>; and</p> <p>(v) The means to avoid, remedy or mitigate adverse effects on <b>adjoining sites</b>.</p>

### 17.2.3 Onsite parking areas - Landscaping -

PI	<p>(a) Onsite car parking area for 5 or more parking spaces located adjoining a road, must comply with the following conditions:</p> <p>(i) The car parking area must be separated from the road by a 1.5m wide planting strip, with the exception of vehicle access points;</p> <p>(ii) Plants within the planting and pedestrian strip must be maintained to a height no greater than 1 metre.</p>
D1	Onsite parking areas that do not comply with <b>Rule 17.2.3 P1.</b>



### 17.2.4 Glare and artificial light spill

PI	Glare and artificial light spill shall not exceed 10 lux measured horizontally and vertically at any point within any other site.
RDI	<p>(a) Glare and artificial light spill that does not comply with Rule 17.2.4 PI.</p> <p>(b) Council's discretion is limited to the following matters:</p> <ul style="list-style-type: none"> <li>(i) Effects on amenity values;</li> <li>(ii) Light spill levels on other sites;</li> <li>(iii) Road safety;</li> <li>(iv) Duration and frequency;</li> <li>(v) Location and orientation of the light source;</li> <li>(vi) Mitigation measures.</li> </ul>

### 17.2.5 Earthworks

- (1) Rules 17.2.5.1 – Earthworks - General provides the permitted rules for earthworks activities for the Business Zone.
- (2) Specific standards for earthworks are within rules:
  - (i) Rule 17.2.5.2 – Maaori Sites and Maaori Areas of Significance
  - (ii) Rule 17.2.5.3 – Significant Natural Areas
  - (iii) Rule 17.2.5.4 – Landscape and Natural Character Areas

#### 17.2.5.1 Earthworks – General

PI	<p>(a) Earthworks within a site must meet the following conditions:</p> <ul style="list-style-type: none"> <li>(i) Be located more than 1.5m from a public sewer, open drain, overland flow path or other service pipe;</li> <li>(ii) Not exceed a volume of more than 250m<sup>3</sup> and an area of more than 1,000m<sup>2</sup> within a site;</li> <li>(iii) The height of the resulting cut, filled areas or fill batter face in stable ground, not including any surcharge, does not exceed 1.5m, with a maximum slope of 1:2 (1 vertical to 2 horizontal);</li> <li>(iv) Areas exposed by earthworks are re-vegetated to achieve 80% ground cover within 6 months of the commencement of the earthworks;</li> <li>(v) Sediment resulting from the earthworks is retained on the site through implementation and maintenance of erosion and sediment controls;</li> <li>(vi) Do not divert or change the nature of natural water flows, water bodies or established drainage paths. ;</li> </ul>
P2	<p>(a) The importation of fill material to a site must meet all of the following conditions in addition to Rule 17.2.4 PI:</p> <ul style="list-style-type: none"> <li>(i) Does not exceed a total volume of 500m<sup>3</sup> per site and a depth of 1m;</li> <li>(ii) Is fit for compaction;</li> <li>(iii) The height of the resulting batter face in stable ground must not exceed 1.5m with a maximum slope of 1:2 (1m vertical to 2m horizontal);</li> <li>(iv) Does not restrict the ability for land to drain;</li> <li>(v) Is not located within 1.5m of public sewers, utility services or manholes;</li> <li>(vi) The sediment from fill material is retained on the site.</li> </ul>

**17.2.5.3 Earthworks – within Significant Natural Areas**

PI	<ul style="list-style-type: none"> <li>(a) Earthworks for the maintenance of existing tracks, fences or drains within an identified Significant Natural Area must meet all of the following conditions: <ul style="list-style-type: none"> <li>(i) Do not exceed a volume of 50m<sup>3</sup> in a single consecutive 12 month period;</li> <li>(ii) Do not exceed an area of 250m<sup>2</sup> in a single consecutive 12 month period;</li> <li>(iii) Do not include the importation of any fill material.</li> </ul> </li> </ul>
RD1	<ul style="list-style-type: none"> <li>(a) Earthworks that do not comply with Rule 17.2.5.3 P1.</li> <li>(b) Council's discretion is limited to the following matters: <ul style="list-style-type: none"> <li>(i) The location of earthworks, taking into account waterways, significant indigenous vegetation or habitat;</li> <li>(ii) The effects on the Significant Natural Area.</li> </ul> </li> </ul>

**17.2.5.4 Hazardous substances**

PI	<ul style="list-style-type: none"> <li>(a) The use, storage or disposal of any hazardous substances must meet the following conditions: <ul style="list-style-type: none"> <li>(i) The aggregate quantity of hazardous substances of any hazard classification on a site is less than the quantity specified for the Business Zone in Table 5.1 contained within Appendix 5 (Hazardous Substances)</li> <li>(ii) The storage or use of radioactive materials is in approved equipment for medical and diagnostic purposes, or specified as an exempt activity or article in the Radiation Safety Act and Regulations 2017.</li> </ul> </li> </ul>
CI	(a) Service station with a maximum storage for retail sale of:

	<ul style="list-style-type: none"> <li>(i) 100,000 litres of petrol in underground storage tanks;</li> <li>(ii) 50,000 litres of diesel in underground storage tanks; and</li> <li>(iii) 6 tonnes of LPG (single vessel storage).</li> </ul> <p>(b) Council's control is limited to the following matters:</p> <ul style="list-style-type: none"> <li>(i) the proposed site design and layout in relation to: <ul style="list-style-type: none"> <li>A. the sensitivity of the surrounding natural, human and physical environment; potential hazards and exposure pathways arising from the proposed facility, including cumulative risks with other facilities; and</li> <li>B. interaction with natural hazards (flooding, instability), as applicable;</li> <li>C. proposed emergency management planning (spills, fire and other relevant hazards);</li> </ul> </li> <li>(ii) proposed procedures for the monitoring and reporting of incidents.</li> </ul>
DI	The use, storage or disposal of any hazardous substances that does not comply with Rule 17.2.5.4 PI.
DI	A service station that does not comply with Rule 17.2.4.5 CI.

**17.2.6 Notable trees**

- (I) Rules 17.2.6.1 – 17.2.6.3 provide permitted rules for notable trees, which are identified in Schedule 30.2 (Notable Trees).
  - (a) Rule 17.2.6.1 (Removal or destruction);
  - (b) Rule 17.2.6.2 (Trimming);
  - (c) Rule 17.2.6.3 (Activities within the dripline).

**17.2.6.1 Notable tree – removal or destruction**

PI	Removal or destruction of a notable tree identified in Schedule 30.2 (Notable Trees) where certification is provided to Council from a works arborist that states that the tree is dead, dying, diseased or unsafe.
CI	<ul style="list-style-type: none"> <li>(a) Removal or destruction of a tree identified in Schedule 30.2 (Notable Trees) that does not comply with Rule 17.2.6.1 PI.</li> <li>(b) Council's control is limited to the following matters: <ul style="list-style-type: none"> <li>(i) Timing and manner in which the activity is carried out;</li> <li>(ii) Effects on amenity values; and</li> <li>(iii) Effects on heritage values.</li> </ul> </li> </ul>

**17.2.6.2 Notable tree – trimming**

PI	<ul style="list-style-type: none"> <li>(a) The trimming of a notable tree identified in Schedule 30.2 (Notable Trees) is either: <ul style="list-style-type: none"> <li>(i) To remove dead, dying, or diseased branches and the tree work is undertaken by a works arborist; or</li> <li>(ii) The maximum branch diameter does not exceed 50mm at the point of severance and no more than 10% of live foliage growth is removed in any single consecutive 12 month period.</li> </ul> </li> </ul>
RD I	<ul style="list-style-type: none"> <li>(a) The trimming of a notable tree that does not comply with Rule 17.2.6.2 PI.</li> <li>(b) Council's discretion is limited to the following matters: <ul style="list-style-type: none"> <li>(i) Timing and manner in which the activity is carried out; and</li> <li>(ii) Effects on amenity values.</li> </ul> </li> </ul>

**17.2.6.3 Notable tree – activities within the dripline**

PI	<p>(a) Any activity within the <b>dripline</b> of a notable tree identified in <b>Schedule 30.2 (Notable Trees)</b> must not:</p> <ul style="list-style-type: none"> <li>(i) Involve excavation, compaction, sealing or soil disturbance and placement of <b>fill material</b>, except for the sealing of an existing road or footpath;</li> <li>(ii) Involve parking or storage of materials, vehicles or machinery;</li> <li>(iii) Discharge of an eco-toxic substance; and</li> <li>(iv) Involve construction of structures.</li> </ul>
RDI	<p>(a) Any activity within the <b>dripline</b> of a notable tree that does not comply with <b>Rule 17.2.6.3 PI</b>.</p> <p>(b) Council's discretion is limited to the following matters:</p> <ul style="list-style-type: none"> <li>(i) Location of the activity in relation to the tree;</li> <li>(ii) Timing and manner in which the activity is carried out;</li> <li>(iii) Remedial measures;</li> <li>(iv) Effect on the health of the tree;</li> <li>(v) Amenity values.</li> </ul>

**17.2.7 Signs**

- (1) **Rule 17.2.7.1** Signs – general provides permitted standards for any sign, including real estate signs, across the entire Business Zone.
